Ordinary Resolution 2:

2. Approved by resolution of the Board as being reasonably incurred for the betterment of the Club.

Notes regarding the Ordinary Resolutions.

- I. The First Ordinary Resolution is to have members approve honorariums for the Board, Bowls Coordinator, Assistant Bowls Coordinator, Bowls Coach and Welfare Officer for their duties performed until the next Annual General Meeting.
- II. The Second Ordinary Resolution is to have members in general meeting approve expenditure by the Club for Directors of the Club to attend seminars, lectures, trade displays and other similar events to be kept abreast of current trends and developments which may have significant bearing on the Club and for other out of pocket expenses.
- III. For Ordinary Resolutions (1) and (2) inclusive to be passed they must each receive votes in their favour from a majority of the members present, who are entitled to vote and who vote on the Ordinary Resolutions.
- IV. The members entitled to vote on the Ordinary Resolutions are Life Members and Full Members.
- V. Members who are employees of the Club are not entitled to vote.
- VI. Proxy voting is not permitted under the Registered Clubs Act 1976.
- VII. Members will be given a reasonable opportunity to speak and ask questions about each Ordinary Resolution.
